2020 Reunion

The coronavirus pandemic has forced everyone to make changes in their lives. Protecting people from the COVID-19 virus became paramount, and functions such as the Glattfelder Reunion were forced to be altered or postponed.

The Casper Glattfelder Association of America, at its May meeting, kept the prospect of a 2020 Reunion alive, opting to move the date from Saturday, July 25, tentatively to Saturday, September 12. The Board then met at Heimwald Park on the original date and decided that it was still not safe or practical to hold a Reunion in September.

It was a difficult decision not to continue our wonderful tradition of a yearly Reunion, but one that was not made for the first time. Twice during World War II, no Reunion was held. However, in at least one of those years, Board members met at Heimwald Park for an informal Reunion.

So it was on September 12 when about 15 board members and guests again gathered at Heimwald. After the annual Reunion business meeting and summer board meeting, most of those in attendance remained for a picnic lunch.

Nine board members were at Heimwald, with four “attending” via teleconference for the two meetings. Board member Philip Glattfelder introduced two guests, Jim McClure and his son Joe. Jim is a York County historian and former editor of the York Daily Record. He has written about the Glattfelders in years past, including items on his blog, Retro York, which he did so again. See a copy of his article later in the Newsletter.

The board approved the minutes from the 2019 Reunion business meeting. Vice president Judy Martin, reporting for the Nominating Committee, confirmed that Directors Dallas Smith, Bonnie Baim, Chris Glattfelder, Larry Gladfelder Jr., Philip Glattfelder and Dean Gladfelder were all willing to serve another three-year term. The annual business meeting was then adjourned.

Summer board meetings

At the first summer meeting, held July 25 at Heimwald Park, 12 board members attended in person and five via teleconference.

Among correspondence, secretary Larry Gladfelder Jr. reported that there were numerous communications from the *contact us* form on the website, mostly inquiring about their lineage. Larry also shared that Kayleigh Glattfelder of the Denver, Colorado, area contacted us after researching the family crest and finding our website.

Treasurer Bonnie Flaharty distributed the financial reports and noted that to date the Association had a net \$1,050 income over expenses. She received an estimate to repair the spouting and roof edge of the pavilion and sent it on to the insurance company. She had already received a check to cover the repairs, less the \$500 deductible.

Board member Rick Gladfelter shared the investment strategy progress, reporting that the investment committee, consisting of Steve Gladfelter, Bonnie and himself, met in May to reallocate the investments as had been agreed upon at the winter meeting. The account lost money in March and April, but with the reallocation done at the end of May, the total had more than recovered. While Rick noted the current allocation has some risk, there is also greater reward.

The committee wrote up an investment policy and Rick recommended that the Board vote to approve the policy, which will be considered for adoption at the next meeting.

Property matters were discussed next, with president Tom Shelley noting the spouting project and moving to repair the damage, which was passed unanimously.

The estimate to repair the roof valley was \$1,200 and a motion to proceed with the repairs passed unanimously.

There was also discussion about putting a metal roof on the Armand Gladfelter building (maintenance shed), but the board decided to postpone that project until next year and get a second estimate.

Phil reported on a project to remove or trim approximately 15 trees of various sizes. More on the tree project later in the Newsletter.

John and Tom Shelley completed the first phase of the fan and lighting project. While working on the project, they found some electrical problems, which were then corrected by John. The board members expressed their appreciation for the labor of love, with the quiet movement of air and the good lighting.

For the reunion committee, Tom said that July 25 was the 311th anniversary of Casper's birth. He then noted that it would be difficult to proceed with the Reunion on September 12, and after some discussion, the board voted to

cancel. Phil suggested that September 12 could be both the Reunion for 2020 as well as a board meeting, and that board members met to hold a "reunion" during World War II. A motion to cancel the Reunion and move the August summer meeting to September 12 at Heimwald Park passed unanimously. Board members will bring potluck items and beverages to share for lunch after the meeting.

For the brick patio committee, Phil reported that Bonnie Baim had picked up 33 bricks from the plant, which were placed after the meeting. While there was no crowd in attendance to view the brick patio, Tom thanked Phil and Dean for their work in cleaning and weeding the patio.

Larry reported for the communications committee that a memorial for Bob Kinsley, a "Friend" of our Association who passed away in June, had been posted on the Association's website for a time.

For the historical committee, Jean reported that a third frame needs a few ribbons to be added to bring it up to date, and she will email a photo for Larry to post on the website when that is accomplished. Phil reported about the program and all the work that Harry Gladfelter has done.

For the Education Fund, Ben Miller reported that Alan Grant Gabosch II has applied for the Nathan Glattfelder and Ives Bricker Scholarship each year for the past four years. He attends the University of Oklahoma and has a 3.84 GPA, and is our scholarship recipient this year.

Ben said the Scholarship's funds are doing well and he is hopeful that a second scholarship may be awarded next year.

In continuing business, the journal of H. I. Gladfelter continues to be a work in progress. Regarding the Steam into History Northern Central Railway now coming to Seven Valleys, it is hoped that the railway will be extended to the Glattfelder Station area in the next few years. In that case, Heimwald Park may be used for picnic excursions and could bring in revenue for the Association.

* * * *

The second summer meeting was held September 12 at Heimwald Park as part of this year's Reunion.

Among the correspondence, board member Philip Glatfelter reported that York County historian Scott Mingus had contacted him via Facebook about a friend with a large collection of photos from the Northern Central Railway, which went through Glatfelter Station. He shared a photo of a woman sitting at the station and was hoping we could help to identify her. His thought was that it was a wife of one of the sons of the Glatfelter paper mill family. Tom suggested it might be a nearby resident of the community or one of the Delp sisters who lived next to the station.

Board member Rick Gladfelter said that the Association's investment portfolio continued to increase. The current allocation is about two-thirds equities, an S&P 500 fund, and one-third low-risk corporate bonds and cash. The investment policy discussed in May constitutes the committee, establishes accountabilities and gives guidelines. Rick moved to adopt the investment policy, which passed unanimously.

For the executive committee, Tom reported that all the officers consented to serve another year.

For the brick patio committee, Phil reported that there were about a dozen bricks to place with a second order for 2020. Tom related a conversation he once had with former president J. Richard Glatfelter, who asked Tom how he would financially support the Association. Tom decided to add bricks to the patio. He explained the various criteria he used to add bricks, and urged board members to consider adding a brick for at least themselves to support the association financially.

For the communications committee, Larry Gladfelter Jr. reported via email that in early August the committee composed and sent out, both by email and USPS, our Reunion Newsletter, including to 494 email subscribers.

In the Newsletter, the Association informed the family of the cancellation of the normal Reunion and included a request for funds toward the removal of trees at Heimwald Park.

Somewhat outside of the committee's scope of responsibility, Larry noted he worked on a

program presentation preview. Check out the program "teaser" on the website (<https://vimeo.com/454541056>) as we look forward with anticipation to the full program that will take place hopefully at the 2021 Reunion!

For the property committee, Tom reported that the roof valley had been repaired, though the gutter repair was not done yet. (Update: The gutter repair is now completed.) The work on the trees was completed, and a pleasant surprise was passed along to Board Members prior to the Meeting/Reunion. More on the tree project appears later in the Newsletter.

For the reunion committee, Tom noted that for nearly 50 years, the Reunion was held on the last Sunday of July, and then, in the 1990s, it became the last Saturday and Sunday in July. Next year's Reunion poses an unusual issue: July 2021 has five Saturdays, the final two being the 24th and the 31st. Rather than the last weekend of July -- a Saturday-Sunday affair -- should we hold the Reunion the last Saturday of July? A motion to have the 2021 Reunion on July 31 passed unanimously.

In continuing business, publication of the journal of H. I. Gladfelter is still a work in progress. Jim McClure, our guest at this year's Meeting/Reunion and York County historian, has a copy, and Tom asked him for recommendations. Jim replied, saying an Amazon service would be one way, and also that he would like fellow historian Scott Mingus to join in on this conversation. Tom recommended that the historical committee work with them on the project, which was passed unanimously.

In new business, Tom suggested that the Association proceed with the idea of setting up an interpretive plaque along the York County Rail Trail in memory of Bob Kinsley. He suggested the plaque be on the north side of the trail as the Homestead becomes visible and would detail the relationship to the family and Bob's work in the preservation of the house. The project would be in conjunction with the Kinsley family and York County Parks.

Tom hopes to have an idea of costs and perhaps a preliminary design ready for the January meeting.

The gift of trees

As was reported earlier in the Newsletter, board member Philip Glatfelter met with Bob Kinsley, a true Friend of our Association for many years, in March to discuss having various trees trimmed or cut down at Heimwald Park.

Not long after, the Association sadly learned of Bob's death. There was uncertainty of whether the tree project, or any other projects that Bob would have helped our Association with, would be completed. Simply, would the Kinsley family also be a "Friend" of our Association.

Eventually, Philip contacted one of Bob's sons, Chris Kinsley, and the project continued with Phil meeting with Ward Behrens, the head of the company landscaping department. Having voted on a \$1,000 limit for the project, and the estimate approaching \$1,600, the Association then determined which trees to have Kinsley take care of and which would be done by various board members.

As things were being finalized, Phil received this email in late August from Ward:

Good Morning Phil,

I have some really great news for you. I just got off the phone with Chris Kinsley. We are going to donate a full day for tree take down. ... I apologize for going through the quoting process, but I misunderstood Chris originally.

Our friendship obviously extends to the Kinsley family, for which the Association is quite grateful.

Among the trees to be taken down were a few that threatened to fall on the driveway and two large dying or dead trees. The crew left numerous cut-up logs and mulch for use by the Association and its members.

As noted earlier, president Tom Shelley suggested that the \$1,000 that the Association had committed to the tree project should be used toward a plaque that would go on the York County Rail Trail in memory of Bob Kinsley and his friendship to our Association.

Phil contacted Chris Kinsley, who expressed his agreement with such a project, which would include the family covering the remaining costs for a plaque.

The Glattfelders and Their Patents

One of the disappointments for this year, along with the cancellation of the Reunion, was the postponement of this year's program. *The Glattfelders and Their Patents* should prove to be one of the more interesting programs that we have ever had.

Harry Gladfelter began with some research about Glattfelder descendants who hold patents, as he does. It ballooned into an amazing list of, as Harry puts it, "rock stars."

It was decided at the July meeting that the presentation would be postponed until next year, rather than pursuing other options, such as posting an online version. However, for the September Meeting/Reunion, it was suggested to have a preview/teaser on our website. Go to www.glattfelder.us to view the teaser.

President's Message: Preserving Heritage While Making History

On September 12, a most unusual Reunion took place at Heimwald Park. For the first time in 75 years (since 1945), there was no public Reunion as such; but the directors, gathered for their fourth meeting of the year, incorporated all of the customary Reunion fare into their meeting agenda.

It was unusual to have held four board meetings instead of the customary three. It was unusual to have held three of the four in the beauty of Heimwald Park. And it was unusual, in those meetings, to have decided first to postpone, and later to cancel, the public Reunion.

The decisions to postpone and then cancel were spurred by the ever-shifting responses to the new coronavirus. While, at this writing, Pennsylvania has been blessed with a rate of infection placing the Commonwealth 44th among the states, restrictions on businesses (especially restaurants) continue and the list of states from which those traveling to the Keystone State are expected to self-quarantine changes on a weekly basis. The "metrics" by which that list is determined also change with little explanation and even less notice. With such uncertainties surrounding the size of outdoor gatherings and interstate travel proceeding with a normal, a public Reunion was simply not feasible.

But against that backdrop, most of the board assembled on the 12th of September, a date which was, ironically, the second weekend of September. The first four Reunions (1906 through 1909) were held on that weekend.

And true to those early (and later) Reunions, the board quickly recessed its meeting to reconvene as the Association, during which time the memorial service was conducted, the directors were elected and recognition was given to the oldest in attendance, the youngest in attendance and the persons coming the farthest distance.

Director Dean Glatfelter (84) was the oldest in attendance -- and nevertheless agreed to re-election to an additional three-year term. I would never have imagined that my son, director John Shelley, at 32 years of age, would be the youngest in attendance, but he was. Those were easy decisions. Recognizing the one coming the farthest distance presented a quandary. While director Sarah Melcher had traveled from Connecticut, director Pamela Tuscany was virtually present from Florida by way of the teleconferencing, which has become an indispensable part of our meetings. So the dilemma was resolved by recognizing both.

And, of course, no Reunion from 1907 onward would have been complete without singing a few verses of Rev. Adam Stump's Reunion Hymn.

We were conscious that while we were preserving the finest aspects of our heritage, we were simultaneously making history: History which we hope and pray may not need to be repeated for at least another 75 years.

The 12th of September is just two days removed from the Universal Feast of the Exaltation of the Holy and Life-giving Cross (also called Holy Cross Day) celebrated on September 14. The opening line of the Orthodox Hymn for the Feast serves as a beautiful summary of preserving heritage while making history:

"Save Thy people, O Lord, and bless Thine inheritance ..."

In the news

As the board members of the Casper Glatfelter Association of America met September 12 at Heimwald Park for what would be both a meeting and a reunion, Jim McClure, a York County historian, former York Daily Record editor and invited guest, looked on, along with his son, Joe. While knowing some of the family's and Association's history, Jim was learning some more about us.

Jim wrote about his experience and observations that day in a column that appeared in the September 20 edition of the York Sunday News. Here is his article...

Safely Reunited; Glattfelder descendants gather for event held since 1906, now adjusted for pandemic

In March 1976, a tornado rushed through York County, leaving behind thousands of dollars in damage and, fortunately, no injuries.

The tornado targeted the Casper Glattfelder Association of America's pavilion at Heimwald Park near Glatfelter Station. The York Daily Record reported the high winds "lifted up" the pavilion and dropped it "into destruction."

The report no doubt was true because the pavilion, scene of the Glattfelder family's annual reunion for decades, was not moored to the ground.

In 1934, the rotten part of the pavilion's support had been removed and the entire open-air structure just rested on the cement floor.

Family has met since 1906

Fortunately, the descendants of Casper Glattfelder are better grounded in their ancestor's home county, and the replacement pavilion on the Springfield Township grounds is, too.

Since 1906, the Association has been meeting around and on the original creek lands settled by the Swiss-born Casper after he arrived in America in 1743, six years before York County was birthed.

In these days of pandemic, the annual reunion met again last weekend, albeit in diminished, socially distanced numbers.

They followed the format of the usual late-July annual gathering with a board of directors meeting drawing on tradition. They opened by singing all six verses of "O God, Our Help in Ages Past" and closed by standing and singing the "Reunion Hymn."

In that closing hymn, those assembled in the pavilion also sang the chorus with every stanza -- no short cuts.

One year, a reunion member observed, the reunion varied from these practices -- sitting or skipping choruses -- and "he heard about that" from an aged family member.

Some board members listened in by phone and voted by voice on the many items on the packed, two-page agenda.

As is customary, they recognized the oldest family member (Dean Gladfelter, 84) and those "traveling the farthest (Sarah Melcher, Connecticut) and Pamela Tuscani (Florida by teleconference).

You could tell that these practices or liturgies at these rites of July -- or September in 2020 -- have played a role in keeping this venerable, sprawling family in contact.

Indeed, this gathering during COVID-19 marked the 115th meeting of the group and the 75th consecutive gathering.

It's not clear that a large gathering of the family met every year in World War II, but did so in 1918, just before the Spanish flu severely ravaged the country.

They came by train

The original Glattfelder family gathered at Springfield Township's Bupp's Union Church in 1906 and later met in woods around the family's first homestead near Glatfelter Station.

In 1913, the association purchased its current two-acre meeting ground, on the hill above today's Glatfelter Station rail trail parking area.

Glattfelder descendants often would travel to the reunion each year via the Northern Central Railroad, departing and boarding the train at Glatfelter Station and walking the short distance to the reunion grounds. Wooden steps, long gone, led from the road to the reunion area.

The land overlooks what was originally Casper Glattfelder's homestead, west of the Codorus Creek. The early 1800s home of Felix, Casper's son, is the old house visible to rail trail users just across the truss bridge along the trail in Glatfelter Station.

Today, the pavilion has another anchor, of a kind. Two sides are framed by a 5,000-brick patio.

The names of about 1,300 family members are inscribed in the bricks arranged under the names of Casper's six sons and reaching 11 generations deep.

A cloud of family witnesses, thus, keep watch on the pavilion and reunion grounds on this hillside overlooking the family's early acreage.

They're there to watch for tornadoes of the bad weather kind, to be sure, but also perhaps to protect against the forces of culture that are so hard on families.

Those witnesses heard 115th anniversary reunion members sing -- or perhaps they joined in -- the first stanza of the opening hymn with the appropriate reference to storms of all kinds:

“O God, our help in ages past,
Our hope for years to come,
Our shelter from the stormy blast,
And our eternal home.”

Brick Patio

About 40 bricks were ordered this year, which were placed after the July and September board meetings. That included new bricks and replacements for damaged ones or updates on death dates.

Board member Philip Glatfelter noted at the September meeting that he has been working on cleaning bricks and leveling several areas. Also, the firm that engraves the bricks noted that their sources for the type of bricks we use have dwindled. With our own inventory of used bricks, both blank and engraved, located behind the Armand Gladfelter maintenance shed, we supplied Olde Mill Impressions with enough bricks for this year's order. We estimate, if needed, we can supply Olde Mill with blank bricks for future orders for at least the next five years.

An updated chart of the brick patio will soon appear on the Association website, along with an explanation of how the bricks are laid out.

Loss of a true friend

Over the years, we have undertaken many projects at Heimwald Park to keep our Reunion place in good order. While Association members have been able to handle some of those tasks, outside help was often needed. Over the past 30 years or so, one person not related to Casper who provided us with great assistance was Bob Kinsley.

Bob passed away in June, and Association board members were saddened, as were many people in York County, to learn of his death.

Bob's contributions were many. His numerous construction and related businesses are quite prevalent in the York County area, and Bob's property holdings surround Heimwald Park. That includes the Homestead, which Bob purchased in the 1990s, renovated and has been renting out.

Kinsley Construction was the main contractor on the Gettysburg National Military Park Visitors Center, which opened in 2008, in part because of Bob's keen interest in history. That interest was a reason for his willingness to help our Association, with its long and rich heritage.

It was suggested that a brick be purchased to honor Bob, and it was placed on the brick patio in July.

As was noted in the Gift of Trees section, president Tom Shelley suggested that a commemorative plaque be placed near the Homestead on the York County Rail Trail, as a joint project of Bob's family, York County Parks and Recreation and our Association.

Board member Philip Glatfelter related that in a meeting with Ward Behrens, who heads Kinsley's landscaping business, Ward expressed how much Bob cared about trees. He said that completing the project for our Association was important to Bob, and it meant a great deal to Ward, since our project was the last one he and Bob worked on together.

Obviously, Bob meant a lot to us, too.

Remembering a key contributor

One of the Casper Glatfelter Association of America's key contributors over the years passed away in 2017.



Dr. John William Glotfelty was instrumental in starting our Association website and was one of the early purchasers of named bricks on our patio. He also made the trip from Florida to attend numerous Reunions over the years.

John, a descendant of Casper through his son Solomon, was the son of Galen Floyd Glotfelty and Mary Susan Boley, born in 1928 in Jefferson County, Iowa. His parents and extended family had lived in the area since their ancestors began settling in the area in the early 1840s.

John attended several one-room schoolhouses in Des Moines Township, graduated from Fairfield High School in 1945 and earned a bachelor's degree from Fairfield's Parsons College in 1948. Among his jobs growing up was as a photographer.

John studied biochemistry and physiology at Iowa State University and attended the

Louisville School of Medicine, where he graduated in 1953, ranked first in his class.

He began his career as a physician as an intern with the U.S. Public Health Service. His service included a stint on a U.S. Coast Guard icebreaker, during which one of his pictures from Point Barrow, Alaska, of a 'blanket-toss' was published in a Britannica Encyclopedia Year Book. He was a highly respected physician and surgeon, practicing until August 2004.

Before heading off to medical school, John married Bonnie Jeanne Dunnuck in May 1949. She was the love of his life and his partner in building his career and raising their six children.

John was an officer and/or board member of most of the medical-related professional associations of which he was a member, including president of the Florida Society of Ophthalmology (1975-76). Governor Lawton Chiles appointed him to the Florida Board of Medicine in 1991, and served in that capacity until 2001.

John had a wide range of interests, but chief among them was his sentimental attachment to his roots in Iowa and his belief in the importance of preserving history for future generations. His initiative, drive and financial support is the reason that the Church of the Brethren in Libertyville, the oldest active church west of the Mississippi River, was rehabilitated.

John died at age 88 and was buried at the Church of the Brethren in Libertyville, where all John's ancestors have been buried since Michael Glotfelty moved to Jefferson County in 1843.

Having just found out about John's death, the Association replaced his brick on our patio this summer with an updated death date.

An interesting note from the minutes of the 2004 Reunion involves John's son Neil, a former CGAA board member: "Neil Glotfelty shared with us that he and his brother were going to County Cork in Ireland, where the boat *Francis and Elizabeth* (which carried the Casper Glatfelter family to America) sank. They are hoping to do some scuba diving to search the boat."

At this point, we have not found any results of their adventure.
